

Nola Loves Summer Competition

TERMS AND CONDITIONS

The promoter is RCL Foods Consumer (Pty) Ltd and CREATIVE AUGMENTATION (PTY) LTD contracted to promote this Competition ("the Promoter").

Any persons entering or participating in this Competition ("Participant") accept and agree that by entering this Competition they have had an opportunity to read and consider these Terms and Conditions and that they are bound by these Terms and Conditions.

What is the Prize

Who can participate

13. The Promoter shall not be responsible for any lost, damaged or delayed entries for any reason whatsoever, and proof of sending will not be accepted as proof of receipt by the Promoter.
